***Public Notice for Applying for the ESSA Federal Grant Funding***

**RAVEN SCHOOL** is submitting the **2024-2025** application for the ESSA Consolidated grant for the year 2024-2025, as follows:

**Title I, Part A**

**Intent and Purpose:** Title I, Part A provides funding for supplemental resources to districts to help schools with high concentrations of students from low income families, and to provide high quality educational opportunities that will enable all students to meet the challenging state academic standards. Title I, Part A supports campuses in implementing a schoolwide program.

**2024 - 2025 Award Amount:** \$39,870

**Intended Uses:**

Payroll for campus positions (\$31,833), ESC6 Title I Part A Fee Service (\$2,137), Homeless reservation (\$100), student online learning system (\$4,200), web-based improvement planning system (\$1,500), operating costs (\$100)

**Title I, Part D**

**Intent and Purpose:** Title I, Part D, Subpart 2 supports the operation of district programs that involve collaboration with locally operated correctional facilities to carry out high-quality education programs to prepare children and youth for secondary school completion, training, employment, or further education; to provide activities to facilitate the transition of such children and youth from the correctional program to further education or employment; and to operate programs in local schools, including schools operated or funded by the Bureau of Indian Education, for the children and youth returning from correctional facilities, and programs which may serve at-risk children and youth.

**2024-2025 Award Amount:** \$68,815

**Intended Uses:**

Payroll for campus positions (\$68,515), Professional/Contracted Services (\$100), instructional supplies (\$100), operating costs (\$100)

**Title II, Part A**

All Title II, Part A funds are REAPed to Title I, Part A

**2024-2025 Award Amount:** \$2,300

**Intended Uses:**

Payroll for campus positions (\$2,000), Professional/Contracted Services (\$100), instructional supplies (\$100), operating costs (\$100)

**Title IV, Part A**

All Title IV, Part A funds are REAPed to Title I, Part A

**2024-2025 Award Amount:** \$10,000

**Intended Uses:**

Payroll for campus positions (\$9,700), Professional/Contracted Services (\$100), instructional supplies (\$100), operating costs (\$100)
